January, the Sanctity of Human Life Month, offers special possibilities for churches and individuals to honor God's gift of life.

Along with offering prayers and sermons upholding life, pastors can invite representatives from local pregnancy support centers to speak and bring information about their life-affirming services (please see pregnancy center directory in this issue).

Sanctity of Human Life Sunday is Jan. 19, but special observances honoring life are fitting throughout January, according to Jon Lindgren, head of Right to Life of the Central Coast.

He would very much appreciate hearing from anyone who can lend a hand with setting up the crosses on Saturdays, Jan. 4, or Jan. 11.

The 2025 national March for Life in Washington, D.C., on Friday, Jan. 24, will have the theme "Life: Why We March." Although it is too far away for most Central Coast residents, walks in two nearby California cities will take place before and after the national March.

#### Los Angeles OneLife LA

In Los Angeles, OneLife LA 2025, with the theme "Let Us Stand Up Together," will begin with assembly at noon Saturday, Jan. 18, at La Placita – Our Lady of the Angels Catholic Church, 535 N. Main St. at the corner of Paseo Luis Olivares.

An expected 20,000+ walkers will set off at 12:30 p.m. for the L.A. State Historic Park near Chinatown. The OneLife LA Festival there will feature speakers, live music, and food trucks. A Requiem Mass for the Unborn with Archbishop Jose Gomez will conclude the day at 5 p.m. at Our Lady of the Angels

# 40 Days for Life Saves 7 in Fall Campaigns

Leaders of 40 Days for Life in Santa Maria and San Luis Obispo report the joyful news that seven lives were saved during the fall campaign of fasting, prayer, and peaceful vigils outside Planned Parenthood abortion centers from Sept 25 to Nov. 3.

Santa Maria sidewalk counselor and 40 Days leader Hilda Cabal credited the decisions for life to the grace of God and prayers of many volunteers—about 100 who signed up in Santa Maria for weekly prayer hours plus numerous others who came to pray.

#### What Abortion Really Is

She described an event from the second day of the campaign: "A car with a young couple pulled into the Planned Parenthood parking lot. The young man driving got out, and I offered him a pamphlet, which he accepted. When I asked him his thoughts on abortion, he gave a neutral response [citing] different opinions.

"But when I asked him, 'What is an abortion?' he paused for a few seconds, then replied, 'Murder.' He returned to the car, spoke with the girl in the passenger seat, then returned to the driver's seat, and smiling told me, 'We're going to keep it.'

"I jumped for joy, thanking God. I then gave the young father information about CareNet, the pregnancy care center just two blocks away."

#### Sylvia's Choice

In another case, Sylvia (not her real name), a distraught unmarried young woman who had been deserted by the father of her unborn child, was heading into Planned Parenthood but stopped to talk with veteran sidewalk counselors Jose Saenz and Hilda.

Their wise and loving counsel persuaded Sylvia to choose life for her unborn child, and Hilda escorted her to CareNet and then to Abba's House, the office of pro-life social worker Beatriz Sanchez, who helped Sylvia, as she has helped many young mothers in crisis, to learn about various community resources that could help her.

#### Volunteers Save Lives

Volunteers who prayed across the street from Planned Parenthood saved two other lives in the fall, Hilda learned.

#### **40 Days for Life Saves 7**

One afternoon, a motorist, who turned out to be a nurse, stopped to thank a family that was praying. With tears in her eyes, she recounted that a patient at the clinic where she works had told her that she had gone to Planned Parenthood intending to have an abortion.

When she saw people praying, however, she realized they were praying for her and her baby, which made her change her mind, leave that place of death, and seek a clinic where she could get the help she needed.

Another volunteer family said that during their prayer hour Melina (not her real name), a young teenager scared about being pregnant, and her boyfriend had stopped to talk with them. Melina was coming to Planned Parenthood to have an ultrasound to confirm a home test that showed she was pregnant.

After a respectful conversation about alternatives to abortion, the family was able to calm Melina's fears and refer her to CareNet and another non-abortion clinic for an ultrasound.

#### **SLO Campaign Saves 3**

In San Luis Obispo, Katie Collins, co-leader of the fall 40 Days for Life campaign there, reports "three saves, which was powerful, wonderful."

Participants in the prayer vigil, who totaled 120, gathered near the driveway to Planned Parenthood and used a strategically parked sports utility vehicle festooned with the names of Tree of Life and LifeLine pregnancy resource centers and a collage of babies' faces to help communicate the protect life message.

The three decisions to choose life and reject abortion each began with lengthy discussions by volunteers with motorists on their way into the center. The drivers and any passengers then went inside briefly, cancelled their appointments, and then drove out. "Faces of concern going in" gave way to "faces of relief coming out," Mrs. Collins said.

She was encouraged to sense that "the community was much softer, more receptive, than in the past." This was apparent from a "lack of negative comments and yelling." Most comments in past years have been negative, but this year were favorable. "We had more thumbs up."

CareNet nationally is a network of 1200 independent pregnancy resource centers across North America. It describes itself as "a Pro Abundant Life ministry that empowers women and men considering abortion to choose life for their unborn children and find abundant life in Christ."

Mr. Warren became CareNet's leader in 2012 after a career in the corporate world with companies such as IBM, PepsiCo, and Goldman Sachs, and 11 years as president of the National Fatherhood Initiative.

He is the author of two books: Raising Sons of Promise: A Guide for Single Mothers of Boys, which draws on his experience as a boy raised in a single-mother home; and Bad Dads of the Bible: 8 Mistakes Every Good Dad Can Avoid, a look at how some of the most revered men of the Bible made major fathering mistakes that all dads can learn from.

He is co-host of CareNet's podcast, "CareCast: CareNet on Family, Faith, and Life." Mr. Warren is married to Dr. Yvette Lopez-Warren and has two sons, Jamin and Justin, and three grandchildren.

### In Grover Beach, LifeLine Center Adds Chat Line, 'Dr. Dad'

LifeLife, the pregnancy resource center in Grover Beach, has been at work on three initiatives in 2024 to reach out to potential clients, including adding round-the-clock chat access to a registered nurse.

"Reaching clients is our No. 1 priority and giving them the resources they need," says Traci Bognuda, LifeLine's executive director.

The new chat line builds on an innovation in 2023, when the center began buying Google search advertisements. When women (or men) in the Five Cities area search via Google for terms like "pregnancy," "abortion," or "abortion help," an ad linking to the LifeLine website with contact information pops up.

The ads have brought clients to the center, Mrs. Bognuda says. After they began, pregnancy tests at LifeLine rose 500%.

#### **Live Chat With Referrals Begins**

After considerable effort to iron out the details, LifeLine in May 2024 began offering via a link on its website live chat with a registered nurse 24 hours per day, seven days per week. The contracted service supplies a nurse trained to offer life-affirming counseling on pregnancy and who can make an appointment for the inquirer with LifeLine. "Our goal is to get an appointment on the books," Mrs. Bognuda says.

The nurse can also offer referrals from a list of community resources (a "referral tree") LifeLine has compiled that can help an abortion-vulnerable woman distraught by economic or emotional implications of a surprise pregnancy to choose life. Such resources can offer help for challenges such as addiction, homelessness, domestic violence, or lack of medical insurance.

The number of nurse chats has been increasing about 20% each month, and about 25% of the chats have resulted in appointments at the center, Mrs. Bognuda says.

#### Dr. Dad Arrives

The second new effort in 2024 for LifeLine is the Dr. Dad program, which began in March and has been gathering steam since. It supports and educates fathers-to-be and new fathers by linking them with male advocate/mentors for monthly meetings and supplying a six-lesson series of video lessons on being a good father that participants work through at their own pace.

"Learning how to be a parent—that legacy—that's what we're trying to create," Mrs. Bognuda says.

Participation has grown since March to eight men and four advocates in November, and the program recorded its second graduate Nov. 21. Graduates are encouraged although not required to become advocate/mentors for newer participants. Participants also qualify for incentives such as a car seat or playpen and a graduation gift card.

#### **Looking Ahead**

The third initiative in 2024 is continuing a five-year plan for possible expansion that started in 2023. A key question, says Mrs. Bognuda: "Does the Lord want us to have a mobile unit or a second location closer to Cal Poly?" The Board of Directors is praying through possibilities and has commissioned a subcommittee to explore working with Save the Stork, a consultant that helps pregnancy centers determine the feasibility of operating mobile units.

Mrs. Bognuda emphasizes that each outreach effort is undertaken only when the Lord brings confirmation through prayer. "We consistently turn to Him to make sure we're on the same page," she says.

The new efforts also carry costs. The contracted chat nurse and referral tree costs about \$10,000 per year, and the Dr. Dad program carries a price tag of \$4,000 for 24 participants.

#### Two Fund-Raisers in 2025

LifeLine has announced two fund-raising efforts for 2025. It will begin its annual Baby Bottle Boomerang on Jan. 19, Sanctity of Human Life Sunday, distributing baby bottles through partnering churches to donors who can fill them with change or cash and return them to benefit the center.

On Friday, June 27, the center will sponsor its Swing for Life golf tournament at Cypress Ridge Golf Course in Arroyo Grande.

# Local Elections Bring Little Change for Pro-Life Cause

Although many elected officials in the Central Coast continued in the grip of the Culture of Death after the Nov. 5 election, some points of light in the city of Santa Maria continued to shine.

When it came to congressional and state legislative seats in our area, the incumbents, who are all proabortion Democrats, most of them members of their party's Pro-Choice Caucuses, handily won reelection. These office-holders are listed on our Legislator Telephone Information page.

#### **Democrats Rule Partisan Races; Steve Garvey Strikes Out**

A few of these races deserve special mention. Democrat U.S. Rep. Adam Schiff defeated Republican Steve Garvey, star first-baseman of the Los Angeles Dodgers of yesteryear, for the U.S. Senate to succeed retiring Democrat Laphonza Butler. Schiff was a member of the House Pro-Choice Caucus. We were not able to determine Garvey's stance on sanctity of life issues.

In Assembly District 37, which covers Santa Barbara County and southern San Luis Obispo County, strongly committed pro-lifer Republican Sari Domingues lost to outspoken pro-abortion supporter incumbent Democrat Gregg Hart.

In District 30, which covers northern San Luis Obispo County and additional areas, "100% pro-life"

Republican Dalila Epperson lost to incumbent prochoice Democrat Dawn Addis.

#### **School District, Santa Maria City Results**

Although abortion was not a campaign issue in nonpartisan school board and city council elections, we chronicle for you the fate of declared pro-lifers who ran. When queried by RTLCC by e-mail whether they were pro-life or pro-choice, several candidates identified themselves as pro-life, one candidate as pro-choice, and the rest did not reply, which leaves you free to make your own judgements about their positions.

In the Santa Maria-Bonita School District (the elementary school district) Area 5, pro-life candidate Zoraida Noratto-White fell short in her bid to unseat incumbent John Hollinshead, 2417 to 2085.

In SMBSD Area 4, your editor, Hunter Jameson, lost to incumbent Ricardo Valencia, 2951 to 1186.

#### **Pro-Lifers Patino, Flores Win**

There was much more encouraging news from the city of Santa Maria. In the mayoral race, Mayor Alice Patino, an outstanding pro-life leader who has frequently spoken at our annual LifeWalk, narrowly defeated Diana Perez, 11,007 to 10,951, to win a fourth term at the city's helm. (Your RTLCC praises God for this result!)

Two other mayoral candidates trailed, William "Will" Smith with 1749 votes, and Andrew "Andy" Foster, 1349 votes. Foster was the only candidate who replied to our inquiry that he was pro-choice.

There was bad and good news concerning Santa Maria City Council Seat No. 2. Incumbent Mike Cordero, a faithful pro-life attender at our LifeWalk, came in third, but another pro-life candidate, political newcomer Gloria Flores, will take his place on the City Council. She edged Benjamin Ortiz, who declined to tell us whether he was pro-life or pro-choice. The very close results: Flores 1969, Ortiz 1923, Cordero 1715.




Thank God for the victory of pro-life candidates who won in the Nov. 5 election.
